INFORMATION: Holy Hill Art and Farm Market is a juried 2 day show held at 4958 Hwy 167, Hubertus- Wisconsin. This unique Marketplace combines a “walk on the farm-park” type atmosphere indoors and outside with a variety of quality exhibitors, music, food and refreshments. The event is held on a 160 year old, 80 acre restored farm homestead. The Market runs on Saturday & Sunday from 9-4pm. All Exhibitors **MUST be 18** years or older. You are required to have personal and product liability policies and additionally name Holy Hill Market LLC and Mary Anderson as additional insured parties. Each Exhibitor is responsible for collecting and reporting sales tax (5.6%) and expected to stay with their displays and remain open during the entire length of the Market. No Exhibitor Pets Allowed in booths or vehicles.

BOOTH SETUP & INFO: **Inside Setup**-Thursday/ Friday before event 11AM-7PM **Outside Setup**- Friday 11-7pm or Saturday of event 7-8:30AM. Booth space measures *approximately* 10 x 10. Each Exhibitor is responsible for supplying, erecting and taking down their displays and booth.

ADDITIONAL INFORMATION: All designs must be **MADE** or **PRODUCED** by the applicant and declared below. Use back side if needed. Tents are strongly recommended for outside. **We do have waiting lists for many spots.**

Events fill quickly - If a Market Date is full or you are not selected for this year's events, your check will be returned to you. Remit ONE check for each date you apply for.
